We want to make our courses and publications accessible to everyone.

The Easy Pay Plan allows you to register for courses and purchase publications now and pay later.

How does it work?

At the time of purchase, we will need one down payment per item from you. (Publications: \$50. Courses: the greater of 10% of the course price OR \$50.) The balance of your invoice will be split equally over the next 4 months, one payment each month.

How do I pay?

To make this convenient for you we'll automatically process a payment on your VISA or MasterCard each month.

What else should I know?

- If you cancel your course registration, your initial payment will be applied toward our cancellation fee. Further charges may apply, pursuant to our cancellation policy. If you return the publication intact, your initial payment will be refunded.
- Your Easy Pay account is interest free.
- You can pay out your Easy Pay account balance without penalty at any time.

What do I do now?

Fill out the application form below and fax it back to CLEBC at 604.669.9260 or email custserv@cle.bc.ca. We will confirm by letter the status of your application as well as your schedule of payments.
